SECTION 4 - FIRST AID MEASURES

4.1 Description of first aid measures

**Inhalation:** It is unlikely that emergency treatment will be required. If product vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. If symptoms persist, seek medical attention.

**Eyes:** It is unlikely that emergency treatment will be required. Immediately flush eyes with large amounts of water or saline solution for at least 15 minutes, occasionally lifting the upper and lower lids. Remove contact lenses, if present and easy to do, after first 2 minutes and continue rinsing. If irritation persists seek medical advice, preferably from an ophthalmologist.

**Skin:** It is unlikely that emergency treatment will be required. Wash the affected area with soap and water followed by thorough rinsing. If irritation persists, seek medical attention.

**Ingestion:** It is unlikely that emergency treatment will be required. Rinse mouth with water if the victim is conscious. Remove dentures, if present. Do not induce vomiting unless directed to do so by medical personnel. Vomiting may occur spontaneously. Never give anything by mouth to an unconscious or convulsing person. Do not leave the victim unattended. Seek medical attention if the victim feels unwell or if a large quantity of material has been ingested.

**Eyes:** May cause mild, transient eye irritation.

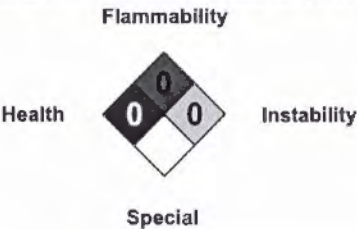
