## 5. Fire Fighting Measures

Flammable properties

#### 6. Accidental Release Measures

Personal precautions

Methods for containment

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Use water spray to reduce vapors or divert vapor cloud drift. Prevent entry into waterways, sewer, basements or confined areas.

Methods for cleaning up

Should not be released into the environment. Stop the flow of material, if this is without risk. Isolate area until gas has dispersed. Following product recovery, flush area with water. Scrub the area with detergent and water. For waste disposal, see section 13 of the MSDS.

### 7. Handling and Storage

Handling
